Dear Faculty,

Here are some updates on relevant happenings and discussions that are going on at the campus and system level. Our next Faculty Representative Assembly meeting is on Friday, March 9.

- **FCQ Redesign Task Force.** The task force has created a new set of question and is soliciting feedback from faculty. David Moon, the Chair of the Task Force, sent an email to faculty-l on Wednesday with the proposed questions. You can provide feedback on the proposed questions in one of the three ways David outlined in his email.
- **Article and Policy 5.** Article and Policy 5 of Regent's Law is undergoing a review. The second draft of the revised Article and Policy 5 is available on the [public website](#) along with an outline of changes in the 2nd draft. I encourage all faculty to look at the draft and to submit comments through the [public website](#). The deadline for submitting feedback on the 2nd draft is April 2.
- **Article and Policy 7.** Article 7 and Policies 7A-7D of Regent's Law are also undergoing a review. This article and policies deal with issues related to students. An outline of proposed changes and the first draft of the policies is available on the [public website](#). Please submit your feedback on the first draft of the policy through the [public website](#) by March 31.
- **Faculty Assembly Special Purpose Committee on Research.** This committee looked at ways to support faculty research and graduate education on campus and has drafted a proposal of goals and action steps for the administration to consider. The Faculty Representative Assembly will discuss this proposal at the next FRA meeting on March 9.

- **CU Online Proposal.** The Board of Regents voted to approve the second part of the online resolutions, which outlines a plan for implementing specific goals regarding online education.
- **Faculty Assembly Elections.** Please consider running for a faculty governance position. We will be electing: (i) representatives from each college; (ii) secretary; (iii) president; (iv) vice president/president elect; and (v) a faculty council representative. The official call for nominations was sent out on February 1st, and nominations (including self-nominations) will be accepted until Monday, March 5th by 5pm. Please submit your nominations/self-nominations directly to Melissa Benton, mbenton@uccs.edu, making sure to verify with your nominee that he/she is willing to run for election. Elections are scheduled for March 19th-23th, 2018. **Please get involved, and consider serving in these important roles.**
