Faculty colleagues,

Last fall, in voting not to adopt the new FCQ questions proposed by a CU system-wide committee, the UCCS Faculty Representative Assembly created the FCQ Redesign Team, which I chair, and charged us with proposing a new set of questions specific to UCCS. As part of that process, we surveyed both faculty and students about each group's preferences. The Team used those results, research on student evaluations of teaching and examples of instruments used elsewhere to formulate a new set of possible questions. Faculty Representative Assembly discussed that draft at its February meeting. The FCQ Redesign Team is now prepared to solicit your feedback.

I have attached the proposed new questions. I will be glad to share the results of either survey with anyone who wants to see them. **We have arranged three means for you to share your feedback with the Team:**

1. I have requested each college to facilitate "department"-level discussions of the questions and asked that they forward me a summary of those.
2. I have scheduled three open forums for you to share your feedback directly with the Team:

Wednesday, April 11, 9:30-10:30 am in **UC 303**

Thursday, April 12, 3-4 pm in **OCSE A327** (Daniels K-12 Room)

Friday, April 13, 10-11 am in **UC 124**

3. If neither of those options works for you, please feel free to e-mail me directly at cmoon@uccs.edu. Please do so no later than Friday April 13.

The Team will consider what changes we should make based on your feedback and forward our recommendation to the Faculty Representative Assembly for their consideration for adoption at their May 4 meeting.
